I, for myself and the Participant(s) named, our heirs, representatives, and next of kin agree to hold harmless and indemnify Inflatable Wonderland – San Antonio and JBJ Consulting & Service Company, LLC, their officers, agents, employees, and other participants with respect to any and all injury, disability, death, or loss or damage to person or property to the fullest extent of the law.

Matching wristbands are provided on entry to match parents with a supervising adult and only the adult with the matching wristband is allowed to take the children out of the facility.
